Please accept my recommendation of attorney Deb Tharnish for the Business Record Women of Influence Award. I have known Deb for over 30 years, both in her capacity as an attorney representing litigants in this Court, and through her myriad of community service roles. She is thorough and ethical in her cases, and has served on Court practice committees. I have seen her work on the Judicial Nominating Commission; she has encouraged diversity in applicants, and helped the Commission give consideration to a wide variety of skills needed to serve on the bench, rather than just narrowly viewing litigation experience as the primary criteria for selection.

Deb's willingness to step up and fill leadership roles in the Iowa State Alumni Association, Big Brothers and Big Sisters, and the Des Moines Public Library Foundation are just a few examples of her willingness to spend time and talents improving the quality of life for Iowans. In addition to community boards, Deb has dedicated time and treasure to support Iowa Legal Aid, which provides direct services to low-income Iowans, and allows courts to operate more efficiently by providing legal services. Deb can always be counted on to assist wherever the need is greatest, helping organizations move forward to complete their missions.

In addition to "big picture" thinking, Deb reaches out to younger lawyers, mentoring not only in her firm, but through the Polk County Women Attorneys and Iowa Organization of Women Attorneys, as an active and founding member for over 30 years. The number of women partners in law firms is not high (either as a percentage of partners, or just in raw numbers). It is important for younger women practitioners to see that you can have an active family life, community life, work life, and be a balanced individual, all within the structure of a law firm. She helped her firm craft policies that enable women to succeed in private practice.

Deb concentrates on business and employment litigation, and is a recognized expert, frequently speaking at continuing legal education programs for lawyers and businesses. She serves on lowa State Bar Association Committees and Sections, networking, and sharing her depth of experience. Deb has demonstrated success and achievement personally and professionally, has invested time and talent in her community, and in mentoring young lawyers. She has blazed a trail for women to follow in the practice of law, and continues to serve as a role model for young practitioners, demonstrating how to achieve work-life balance, along with community service.
