Ruth Randleman was elected Mayor of the City of Carlisle in 2003. Prior to this position she was a member of the Carlisle City Council since 2000. She is a Registered Nurse with a teaching certificate in Post Secondary Health Occupations. She was the instructor for the Health Occupations Program for Carlisle Community Schools 1998 - 2006, teaching at the Jr. High/Sr. High level. In her role as President with the Iowa League of Cities and as an elected official, she has spoken with legislators on various issues, and related experiences for Iowa General Assembly Senate Subcommittees on smart planning, property tax issues, and gender balance. At present, Mayor Randleman serves as Board of Directors Chair for the Iowa Finance Authority. She has chaired and served as president or officer for numerous regional, state and national level organizations or committees. As representative for her community, she has served at several levels with the Des Moines Metropolitan Transportation Organization. As an advocate for health and wellness, Mayor Randleman has served with several committees and made local efforts regarding bicycle/pedestrian accommodations and been active in obtaining funding for community projects. Mayor Randleman's local efforts have included planning and implementation projects for the City of Carlisle, including submitting a grant application for a Walkability Audit utilizing national level experts that travelled to Carlisle.
