I'm proud to submit this letter of recommendation for Ellen Willadsen to be named the 2018 Deloitte CFO of the Year! I truly believe she is the best CFO I've ever worked alongside, and I can't think of anyone who is more fit for this award.

Ellen consistently exceeds expectations, tackles all tasks with dedication and a positive attitude, and is an excellent leader. But even more than that, she's a trusted advisor.
