

Executive Summary

BHC, LC is a wholly owned subsidiary of UnityPoint Health. BHC consist of two subsidiaries, HNc Services Inc. and Broadband Inc., dba BroadNet connect ("BNc"). Through these subsidiaries BHC offer tremendous opportunities to develop business, improve efficiency and lower costs by providing business, communications and technology services to health care providers, business organizations, education and local government. The foundation is a private fiber optic network and data center infrastructure. The definition of the subsidiaries are as follows:

<u>HNc Services Inc.</u> is a communication and information technology services company providing value added services to the HealthNet connect consortium and the general health care community. <u>BroadNet connect</u> is a communication and information technology services company providing valued added services to community anchor institutions (education and local government), and businesses.

<u>HealthNet connect, LC ("HNc")</u> is a wholly owned subsidiary of UnityPoint Health and a consortium of health care entities sharing a common goal of instantaneous communication of medical information by utilizing and sharing technology.

Together these companies form HNc|BNc and are connecting hospitals, businesses, education and government organizations throughout the mid-west to our fiber optic network and data center infrastructure.

In early 2015, we will be offering a new service called mobile device management. This will allow health care organizations and businesses to see, control and secure the mobile devices entering their organizations, whether they are provided by the company or part of a Bring Your Own Device (BYOD) program.

Commercial Impact on Innovation

HNc|BNc started from grant projects to build a robust, secure fiber network infrastructure for health care and community anchor institutions. We have exceeded those goals and have built a sustainable business.

We have over 100 hospitals and clinics connected to our infrastructure and sharing critical information between Iowa, Nebraska and Illinois. We will be moving into Wisconsin in 2015. We have over 50 businesses we provide high speed transport and internet services to. We have connect cities in rural areas and provide education institutions high speed connectivity. All of this and we have not completed our 2nd full year of operations.

Our revenues have gone from zero to \$1.5 million in our 1st year of operation. We will finish our 2nd year of operation with \$3 million in revenues and 2015 is projected to come in at \$5 million in revenues. That is consistently over 50% increase in revenues Y/Y.
