Dear Forty Under 40 Nominating Committee:

I am pleased to nominate Nola Cartmill for Forty Under 40 recognition.

Of the many nominations that I have made to Forty Under 40 and the Greater Des Moines Leadership Institute over the years, this is one that I am most pleased about making. Let me tell vou the story.

Our law firm's strategy for hiring lawyers is to recruit from the best talent from the summer intern pool of first year of law school students (Note, it is not the second year, but the first year). It would simply be too difficult to compete against the money market firms for that type of talent for second year students. Because the large firms do not recruit in the first years, we have a chance for the best students from the most respected law schools in the country.

Nola Cartmill is one of those lawyers. Nola is self made and continually improving. Growing up with limited means the middle of four children in Fort Madison, she excelled academically. Hard work at Fort Madison High School earned her valedictorian status. That led to several scholarships, which allowed Nola to attend the University of Iowa, where she graduated with distinction. Based on merit, she was admitted to Harvard Law School. Harvard admitted Nola on academic achievement and test scores. Because of her performance, she was asked by Kaplan to teach the LSAT review course (the LSAT is the entrance exam to law school; Kaplan is a national leader in LSAT review courses).

During the second year of law school, we ask our law students to take an alternative choice of summer employment. If a student decides to come to Des Moines, it is based upon a full and complete comparison and they make a professional and lifestyle choice to accept a job in our firm and move to our city. When students work at big firms in large cities in their second summer, we do require they spend a week with us before returning to the final year of law school.

Nola worked that second summer in the Chicago office of the venerable law firm Jenner & Block and then she came for a week to Belin McCormick in Des Moines before she started her third year and began interviewing. we had lunch. At lunch she said "Mr. Zumbach, as I was driving back to Des Moines, it just felt like home."

She could have easily remained in Chicago—her boyfriend's hometown; Nola's sister worked for Oprah Winfrey at the time. Nola accepted our offer at Belin McCormick and chose to build a career in Des Moines, a city where she could make a significant and immediate impact.

In our firm she has excelled. She has a deep sense of community. She is a board member of Children & Families of Iowa and is a board member of the Des Moines Pastoral Center. She is also a past board member of Whyld Girls.

She has a disarming, quiet, gentle personality but internally she is as focused and determined as the toughest driven lawyers in our profession. It is a wonderful combination.

Growing up with modest means in a river town in Southeast Iowa and subsequently achieving at the highest levels at the University of Iowa and Harvard Law School will bring a special, unique dimension to the Forty Under 40 class. She will enrich the experiences of her classmates.

I give Nola my strongest recommendation.
