- Participated in multiple strategic planning committees including Health and Fitness and chairing the Green Committee on environmental improvements. Currently working on the Plan 9 committee. This committee identifies and engages in the full utilization of partnerships that Iowa Legal Aid has with community partners.
- Complex trial and appellate representation of Iowa Legal Aid clients in many areas of law.
- Supervising of Interns. Including mentoring on trial litigation and supervising student practice attorneys while they provide representation in administrative and judicial actions.
- Supervised and oversaw two different grants: Supportive Services for Veteran's Families and the Health and Law Project.
- Acted as the lead attorney for the Health and Law Project. It is designed to connect patients served through Primary Health Care with Lawyers to address underlying legal issues that are impacting their health status. The goal is to alleviate health problems through legal representation, when traditional medical approach cannot cure the problem due to a legal barrier.
- Acted as the lead attorney for the Supportive Services for Veterans Families program.

  Representation of homeless or near homeless veterans that have legal barriers to permanent

- housing. Oversaw and approved the billing of our staff's hours on this grant prior to submitting it to the lead grantee, Primary Health Care.
- Currently acting as the sole attorney for the Medical Legal Partnership between Blank Children's Hospital and Iowa Legal Aid. This partnership serves the specific legal needs of sick children and their families and has granted people access to: safe and healthy housing, relief from violence, reduction of debt, establishment or termination of guardianships as medically necessary, and access to education by establishing Individual Education Plans and 504 disability plans for students.

#### Representative Cases

- EQCE073786 The city of Des Moines attempted to evict homeless people from public land during life threatening conditions. The case was heard first by an administrative hearing officer before being appealed to District Court. The homeless were successful each time. The city was stayed from evicting the clients for over one year. The case was argued in front of the Iowa Court of Appeals. The Court of Appeals ruled against the clients. The case did establish the position that the defense of necessity is available in Iowa in a civil cases.
- CDCD085936 The opposing party in this case had primary physical care of the child though the child had lived with the client for 2 years. The child is very ill and in need of a kidney transplant. The opposing party would not comply with the medical requirements so that the University of Iowa could schedule the transplant. The child was in danger of dying. Physical custody and sole legal custody was granted to the client through a modification action that allowed him to authorize the life-saving transplant without the involvement of the non-compliant parent.

#### Civic Leadership

- For several years I have worked on a planning committee of graduates of the University of Iowa College of Law and Drake University Law School on the Dean's Cup Golf Challenge. This event has raised \$65,000 during my tenure on the committee.
- This competition is between alums, faculty and students of the law schools. The event is entering its twelfth year. Current participation and revenue are at all time highs.
- Undertaking a project with the Faegre, Baker, Daniels Law Firm to support volunteer attorneys with the firm in conducting intake and pro bono representation of patients of Primary Health Care through the PHC Health and Law Project. This collaboration has been fruitful in obtaining premier attorney services for low-income individuals that may have otherwise been remained unrepresented.
- Present training to corporate legal departments looking to volunteer their services to Iowa Legal Aid. Examples of these corporate legal departments include Principal, John Deere and Wells Fargo.
- Served on the board for the Lower Beaver Neighborhood Association for two terms from 2013 until 2015.
- Recently co-founded the non-profit 501(c) corporation Douglas Avenue Coalition. This organization works closely with officials from the City of Des Moines, Polk County Board of Supervisors, and the State of Iowa on securing resources for the revitalization of one of Des Moines busiest stretches of road, Douglas Avenue between Martin Luther King and Lower Beaver.

- Two months of the year my family and I sign up to be caretakers of Woodlawn Park. We clean the park two times a week and inspect the premises to make sure things are in working order.
- Participation in homeless camp cleanups with JOPPA Outreach. This event cleans up tons of garbage every year that would otherwise pollute Des Moines.

- Volunteer at my children's schools to assist in the classroom.
