It is my privilege to support the nomination of Michael Thibodeau, J.D. of the Simpson, Jensen, Abels, Fischer & Bouslog Law Firm for the Business Record Forty Under 40 recognition. Iowa Community Capital (ICC) is a small 501(c)(3) nonprofit startup community development financial institution. ICC has been launching a peer group microfinance program called Solidarity Microfinance designed to assist low income minority women in Des Moines who are interested in starting or enhancing a small business enterprise. ICC's Solidarity Office is located near the corner of Forest and Sixth Avenue in Des Moines.

Michael has volunteered countless hours of time and legal expertise at no charge during the past three years during Solidarity program organization and implementation. After learning about the concept three years ago, he volunteered to serve on the ICC board to help shape, organize, and implement the Solidarity Microfinance program. During this time, Michael's legal counsel and advice assisted ICC with a significant initial capital campaign, hiring of staff, opening of an office, engaging consultants, executing grant agreements and implementation of lending operations. ICC's first year of lending resulted in the formation of 16 Solidarity Groups with 81 members from low income target populations in the Greater Des Moines Area. These groups meet weekly to discuss their enterprises, make loan payments and deposit savings as they improve family incomes, learn business and leadership skills, and build community networks.

Michael is truly a young visionary leaders in Des Moines who is willing to volunteer his time and expertise to help a startup nonprofit create a new program for building community vitality by providing assistance to those who have a good business idea and who can be successful if they are given an opportunity for very small loans in a supportive Solidarity group setting. The success of the ICC-Solidarity accomplishments so far would not have been possible without access to Michael's legal expertise and his significant contributions of time and effort.
