This has given me a vantage point to form an opinion about her strengths as a candidate for the award. For the last three years I have also had the privilege to serve with Amber on the Ames City Council.

For many years, Amber has been very intentional about finding ways to make our community a better place for all its citizens. She is an articulate and passionate leader on behalf of many who would not otherwise have a voice. Prior to Amber's service on the city council, she served two terms on the Ames Humans Relations Commission. This Commission provides a critical role in safeguarding the civil liberties of our citizens.
