Executive Summary

John Rigler, 35, is a Senior Private Banker with Wells Fargo in Des Moines. Past professional experience includes involvement in JP Morgan's acquisition of Bear Stearns during the 2008 financial crisis and work in mergers and acquisitions of aerospace and defense companies in Washington, DC. When large segments of the financial system froze in 2009 John successfully closed two multifamily loans through Freddie Mac to a Las Vegas property owner who was then able to successfully navigate his way through the recession. As a student majoring in Finance and Real Estate at the University of Wisconsin-Madison John was the sole undergraduate recipient of a scholarship awarded by the Puelicher Center for Banking Education. In 2011, he received an MBA degree from the prestigious Kellogg School of Management at Northwestern University. During his career, John has participated in closing over two billion dollars in commercial real estate, aircraft, home mortgages and other credit. At Wells Fargo, he has managed new real estate asset management business across their 13-state Great Lakes Region, which most notably included the acquisition of a large, diversified portfolio of commercial and agricultural real estate for a high net worth client. John has also closed new brokerage and fiduciary asset management business. Over his 13 year career, John has remained involved in the local business and non-profit community. John's father presides over the bank today as it continues to have a positive impact on the economic landscape of eight northeast lowa communities and the surrounding area. John has continued the Rigler tradition of positively impacting his local community in ways that lead to a better place for his children and future generations. John has traveled to 16 countries including four in the former Eastern Bloc and most recently the country of Turkey. Three organizations get the opportunity to present at each meeting. The group votes by secret ballot and the majority directs 100% of the donations (\$10,000+ for the winning organization).

Habitat for Humanity Volunteer – John helped paint houses on Des Moines' east side and in New Hampton, IA, as well as donated building materials to the organization's Re-Store. Each effort helped contribute to the organization's goal of helping families break the cycle of poverty and build long-term financial security. With an affordable, stable home, families have more to spend on food, medicine, child care, education and other essential elements of life.
