Dear Forty Under 40 Nominating Committee:

Three years ago in an introspective moment, I made of list of the people in my life whom I believe are making a difference for good in our community. Among others, that list included six young women who are bright and focused, who care about other people and the community in which we live. These are the people who bring me hope. Among the names on my list is Leslie Behaunek.

I first encountered Leslie Behaunek when I was president of the Des Moines Choral Society, a now 38-year old Des Moines performing ensemble. The most important task in any non-profit organization is to produce a solid slate of board members and officers who will fulfill their fiduciary responsibility to ensure a solid financial foundation for the organization so that the organization can fulfill its mission. When the nominating committee met in the spring of 2012, Drake Law School professor, Cathy Lesser Mansfield, remarked that she had a student who was looking for a significant way to become a part of the fabric of the Des Moines community. Realizing that the way to learn a community is to get involved, she first served as cochair of the silent auction for our annual *Society Celebration* fund raising event. She went on to serve as Vice President for Community Outreach, where she honed her marketing skills as she learned how the greater Des Moines community shares information and what timelines are involved to most effectively present a message.
