I prefer to go about my work quietly; boosting the recognition and visibility of other people and the organizations for which I work and volunteer over my own. However, I have been approached over several years by past Forty Under 40 honorees, peers, and colleagues, to be nominated for this prestigious distinction and am honored to be considered.

As evident through a review of my resume, I have achieved a great amount in a relatively young professional career. Just a year out of graduate school and at the age of 25 I joined a new management team as part of a turnaround operation at a 340-bed tertiary hospital in New York. I quickly became a trusted member directing projects and developing service lines across the organization. Though my time in New York was relatively short I quickly became a leader entrusted with building new programs including a neurosciences institute, orthopedics institute and pain management and wound care clinics.

Expecting our first child, my wife and I decided it was time to come back home to Des Moines and be near family. I landed at Mercy Medical Center as the director of radiation oncology and the only CyberKnife center in the state. During my time at Mercy I led a multidisciplinary staff of 40 physicists, dosimterists, therapists and nurses, in a 6 physician practice. I developed the business plan for the comprehensive outpatient cancer center on the Wellness Campus in Clive, co-authored a state certificate of need application, and negotiated multi-million dollar purchases and contracts. I guided the team for nearly 6 years as we added new clinical services, replaced multi-million dollar pieces of equipment, and increased volumes and profit margins.

In the last year I moved to Des Moines University to run the multi-specialty clinic, providing oversight and guidance for over 25 licensed providers in 5 specialties, and ancillary and administrative services. I am leading our transitions to digital x-ray, a new electronic health record, ICD-10 coding compliance, and our clinic strategic plan. In addition to these responsibilities I am chairing faculty search committees and serving on a number of high level committees and workgroups with leadership from across the university.

Outside of professional accomplishments, my move back to Des Moines has afforded me personal growth and fulfillment. I became an active volunteer serving on a number of not-for-profit boards. I have served as president and chairmen of the Prevent Blindness Iowa Board where I have also been the top individual fundraiser the last two years for Light the Night for Sight, our largest annual fundraiser. I am also the treasurer of my synagogue board, providing financial oversight and helping raise funds to ensure our financial health. I am a graduate of the West Des Moines Leadership Academy and had the privilege of serving on their board of directors for 3 years, helping guide the strategic direction of the program. My most recent endeavor has been with 100 Men on a Mission, a group that has raised over \$40,000 in its first year for local not-for-profits.
