Ladies and Gentlemen:

We are proud to nominate Michael K. Thibodeau for the 2015 class of Forty under 40.

Mike is an officer and shareholder in our firm. He attained these positions through repeatedly demonstrating professional competence, diligence and zealous advocacy. He brings these same qualities to the board room where he plays a key role in the management of our firm. Mike is also a mentor to younger attorneys, law students and staff. Outside the office, he serves the community through leadership roles in several worthwhile organizations (e.g., President of the Greater Des Moines Music Coalition and Past President of the Rotary Club of West Polk County).

Mike literally kept our law firm in business following a fire in the Equitable Building over Labor Day weekend in 2014. Most of the firm's attorneys were out of town on vacation when Mike heard the first news reports of an early Saturday morning fire in the crawl space directly above our offices. Mike closely monitored developments all day, and he was one of the few people to enter the building immediately after the fire department permitted limited access. The building was dark and still filled with the chocking stench of smoke. He waded through several inches of foul water and debris to get to our offices. Mike retrieved the firm's central computer server and its critical components enabling us to resume relatively normal business activities in a matter of hours. Without Mike's quick thinking and selfless efforts, we would have been unable to function for many days. Shortly after Mike's trip into the building, the State closed all access to the building for over a week.

When Mike isn't busy rescuing our firm, he accomplishes great things for our clients. For example:

- Mike stopped a major national bank from wrongfully foreclosing on a home.
- Played a key role in bringing the first large grocer to a community needing one.
- Represented the Federal Government (FDIC) in the US District Court.

- Successfully argued several cases before the Iowa Appellate Courts.
- Developed a winning argument for a major property tax appeal while other well qualified attorneys were losing cases involving the same issues.
- Counseled a bank during an extended period of FDIC supervision.
- Prevented bank fraud through litigation before the US Bankruptcy Court.
- Completed many business transactions involving acquisitions, organizations, negotiations and closings.

Beyond Mike's many accomplishments as a lawyer, he is also active in the community. Mike's life outside the office is described in the other letters and materials accompanying this nomination letter. Left to his own devices, Mike would not seek out recognition for his many accomplishments. However we, his friends and colleagues, cannot idly stand by.
