In this age of shameless self-promotion and internet exaggeration, Katie Graham is breath of fresh air – someone who serves her community with quiet competence.

Katie is clearly a leader in the legal profession. Despite her youth, Katie is an experienced trial lawyer and recognized leader in the bar. She put herself through college and law school. She graduated magna cum laude from the University of Iowa School of Journalism and Mass Communications while working full-time and serving as the fundraising coordinator for the Make-A-Wish Foundation. Katie was an editor of the Drake Journal of Agricultural Law while also serving as a law clerk to one of her mentors, Roxanne Conlin.

While this may seem like a small thing, it was incredibly vital to a dozen immigrants who represent the future of our community and our country.

Katie is modest. She is not preoccupied with the material things of this world. In fact, the most "expensive" thing that Katie owns is a cat with leukemia that was given to her by one of her mentors.

In closing, and in all seriousness, the real puzzle with Katie Graham is how she finds time to sleep given her active legal practice and dedication to her community. I cannot think of anyone better qualified to be accorded the honor of 40 Under 40. I invite you to call me if you have any questions. You might also call my good friend, Roxanne Conlin. To Whom It May Concern:

I have known Katie Graham since she came to work as my law clerk in 2009. I immediately recognized in her intelligence, the courage of her convictions and the willingness to work as hard as necessary to achieve her goals. Her work for us was uniformly excellent. She was instrumental in preparing for a trial involving a child who was molested by a temporary part time maintenance man at a low income apartment building who was on the sexual offender registry. Katie wrote the brief opposing the defendant's late attempt to have the molested child examined by a psychologist of the Defendant's choice. The effort to preclude the examination was successful. The case settled on the eve of trial due in part to the great work Katie and the other law clerks did in our pretrial filings, including a brilliant trial brief and proposed jury instructions. The settlement resulted in resources sufficient to provide education for the child and psychological care for him for his lifetime.

She worked on two cases involving the rights of deaf people to understand the medical care they or their loved ones are receiving. One involved a deaf woman whose deaf husband died in the hospital without either of them ever understanding the nature of his condition or the treatment he was being given, despite federal law requiring that they be supplied with a sign language interpreter. The second case involved the hearing daughter of a deaf woman who died without ever being provided with the federally required sign language interpreter while she was in the same hospital. The settlement in that case, which occurred after she left us recognized the problem and addressed everything our clients thought would help to assure that deaf patients and their families would never again face the terror these two families faced while their family members died.

Katie was particularly gifted at dealing with clients and potential clients. Our clients are frequently people in crises who can be depressed, hysterical or difficult or all of those things at once. . Katie invariably dealt with every single one of them with compassion and concern. Many complimented her to me because they felt she was so helpful to them.

She has, since her graduation continued her fine work, though now most of her cases are representing businesses. We have had some cases against each other, and I have learned again about her creativity and fierce devotion to her clients and their cases. She was one of my most accomplished law clerks and one of my favorite people.

Katie has also continued her community and professional service, volunteering on boards and commissions and lending her expertise to many worthy causes. She has great organizing and management skills together with boundless energy and a sincere desire to improve our profession and our community.

Katie has overcome many daunting obstacles with courage and tenacity. She certainly deserves to be honored. Please feel free to contact me if you have any questions.
