Jenna's tireless efforts and leadership in the area of affordable housing and neighborhood development make her a leader to watch not only in the nonprofit arena but also in the Greater Des Moines community.

As a board member of Greater Des Moines Habitat for Humanity (GDMHFH) for the past year, and a volunteer with the organization for much longer, I have seen first hand how dedicated Jenna is to ensuring everyone in Central lowa has a decent and affordable place to live. Truly, I'm not sure how the organization could operate without her. She has achieved great success in growing fundraising efforts and diversifying funding sources for GDMHFH, which has been key to helping the organization grow the number of families served from 186 in 2015 to 272 in 2017. She also single-handedly started a Habitat Young Professionals chapter in 2011 to build a pipeline of volunteers and leaders to replace an aging volunteer base.
